USE ON: Auto Motors, Garbage Cans and Trucks, Dumpster, Concrete, Masonry, Road, Farm and Construction Equipment

NOTE: Do not spray into or on electrical equipment. Pretest on paints and plastics.

DIRECTIONS: Direct actuator at area to be degreased, holding can approximately 8 inches away. Spray liberally. Allow to penetrate grease, tar or grime. For heavy deposits, allow extra time. For stubborn spots, agitate with a brush. Wipe area clean with a damp cloth or rinse thoroughly with water.

DANGER: Contains Citrus Terpene (5989-27-5), Nonylphenol Ethoxylate (127087-87-0) and Carbon Dioxide Propellant (124-38-9). Do not use near heat, sparks or open flame. Avoid contact with eyes or prolonged contact with skin. Do not puncture or incinerate container. Do not expose to heat or store at temperatures above 120°F.

FIRST AID – IF EYE CONTACT: Flush with large amounts of cool running water for at least 15 minutes while holding upper and lower lids open. If irritation persists get medical attention immediately.

IF SKIN CONTACT: Wash with soap and water. If irritation persists seek medical attention.

EXCESSIVE INHALATION: Remove to fresh air. Seek medical attention immediately. If breathing stops give artificial respiration.

IF INGESTED: Do not induce vomiting. Seek medical attention immediately.
